SECTION 2 - HAZARDOUS INGREDIENTS/IDENTITY INFORMATION

Hazardous Components (specific chemical identity/ Common name): 1ml or 10ml of

SOLIDS: **MAbsorbent A2P HF** 6% Agarose containing Galactose polysaccharide >98% with attached coloured (non-toxic) Ligand <2%

LIQUIDS: **Preservative Base** containing aqueous Ethanol 20%

NOTE: Plastic column, end caps & tubing are non-hazardous under normal operating conditions.

SECTION 3 - HAZARD INFORMATION

Treat as inert / Non-hazardous. No toxic / ill effects under normal operating conditions. Repeated or prolonged exposure is not known to aggravate any medical condition.

Inhalation: Slightly hazardous
Ingestion: Slightly hazardous. If ingested in quantity 20% ethanol may cause alcoholic poisoning.
Skin contact: Irritation may occur. No data on sensitisation. May have drying effect, especially on mucous membranes
Eye contact: 20% ethanol - Irritating to eyes.

SECTION 4 - FIRST AID MEASURES

Skin contact: Remove contaminated clothing and shoes. Immediately flush skin with copious amounts of cold water for at least 10 minutes, then wash with soap and water.
Eye contact: Check for and remove any contact lenses. Immediately flush eyes with copious amounts of water for at least 15 minutes.
Ingestion: Wash out mouth with cold water provided person is conscious. Seek medical advice. Do not induce vomiting unless directed by a physician. 20% Ethanol if ingested in large quantities may cause alcoholic poisoning.
Inhalation: Remove to fresh air. Seek medical advice if symptoms occur.
Always seek medical attention if irritation continues.

SECTION 5. FIRE-FIGHTING MEASURES

Suitable extinguishing media: Water spray, dry chemical powder or appropriate foam.
Special fire fighting procedures: Wear self-contained breathing apparatus and protective clothing to prevent contact with skin and eyes.
Unusual fire and explosions hazards: May emit toxic fumes under fire conditions

SECTION 6 - ACCIDENTAL RELEASE MEASURES

If contents of column have spilled out - Take care floor surface will be slippery at site of spillage.
Wear chemical safety goggles, splash suit, rubber boots and gloves.
Adsorb onto adsorbent paper. In case of large volumes, use sand or other inert material. Prevent spillage from entering drains. Do not touch spilled material. Place in a bag/other appropriate non-hazardous container and hold away from ignition sources/heat for waste disposal. Ventilate area and wash spill site with water after material pickup is complete.

SECTION 7 - PRECAUTIONS FOR SAFE HANDLING AND USE

Steps to be taken in the event of spillage or chemical release: Wear suitable protective clothing.

Waste disposal method: Column contents to be disposed of in accordance with national and local regulations for inert non-hazardous waste material. Dispose of plastic parts in accordance with national & local regulations for inert non-hazardous "other plastics" code 200106 (European Waste Catalogue) material can be recycled.

Precautions to be taken in Handling and Storage: Store in a cool, dry place at room temperature (15 to 25°C recommended) in original sealed containers away from heat sources and sunlight. Do not Freeze or overheat, as this will affect column packing and contents. Avoid contact with strong oxidants and strong acids.
